

NOTIFICATION

The following declaration made by a resolution passed at a meeting of the Executive Committee of Indian Nursing Council held on 25th July, 2019 under section 10 of the Indian Nursing Council Act, 1947 (48 of 1947) is hereby published, as required by Sub-section(1) of Section 15 of the said Act, namely:-

Recognition of the Basic B.Sc. Nursing and Post B.Sc.(N) qualifications granted by the Y B N University, State Private University, Ranchi, Jharkhand on or after 25th July, 2019.

WHEREAS, the Y B N University, State Private University, Ranchi, Jharkhand being an authority recognized by the Government of Jharkhand vide Y B N University Act, 2017 (Act no. 15, 2017), Gazette Notification No. 505, Dates 17th July 2017 as per section 2 (f) of UGC Act 1956 has applied to the Indian Nursing Council constituted under the INC Act, 1947 (48 of 1947) as amended from time to time that the qualifications granted by it in Basic B.Sc. Nursing and Post B.Sc.(N) qualifications be recognized for the purpose of the said Act subject to the following condition from 25th July, 2019 onwards:

- No distance education under Nursing can be offered by the University.
- No Nursing program including Ph.D (N) can be offered without the permission of Indian Nursing Council.
- Only those programmes / qualifications shall be offered which are prescribed / recognized by INC. Just changing the nomenclature of the courses i.e. Home care provider etc. shall not be offered by the University.
- Nursing Faculty shall be a member of examination/Academic Board/Council.
- Faculty of Nursing should be independent and not under the Faculty of Science/Faculty of Medicine.
- The copy of examination schedule shall be provided to INC every year.
- Indian Nursing Council may conduct the inspection during the period of examination.

Now, the Executive Committee of the Council at its meeting held on 25th July, 2019 for the said purpose resolved that the following qualifications when granted on or after 25th July, 2019 shall be recognized qualifications for the purpose of the said Act namely:-

“Basic B.Sc. Nursing and Post B.S.(N) qualifications granted by the Y B N University, State Private University, Ranchi, Jharkhand on or after 25th July, 2019”
